RESOLUTION

CONDEMNING IN THE STRONGEST POSSIBLE TERMS THE DISGRACEFUL GRENADE EXPLOSION THAT TRANSPIRED IN LA PAZ, ABRA, TO EXTEND ITS DEEPEST CONDOLENCES AND SYMPATHIES TO THE FAMILIES OF THOSE WHO WERE KILLED AND INJURED AND TO EXPRESS SUPPORT TO HON. JOSEPH "STO NINO" B. BERNOS IN HIS EFFORTS TO PROTECT HIS CONSTITUENTS AND SEEK JUSTICE FOR THIS HEINOUS INCIDENT

WHEREAS, in the morning at about 1:30 a.m. of January 25, 2018, a grenade explosion tore the peaceful gathering of the La Pazeños to witness the fireworks display in celebration and honor of their patron saint, Nuestra Señor de La Paz that claimed the lives of Police Officer (PO) 3 Carlos Baccali Bocaig and PO2 Frenzel Buneng Kitoyan, both members of Abra Provincial Police Office and left sixteen others injured including Hon. Joseph "Sto. Nino" B. Bernos and his wife, Mayor Menchie Bernos;

WHEREAS, the heinous and shocking incident shattered the reign of long-standing peace and order of the Province;


WHEREAS, House Representatives who are members of the Special Committee on North Luzon Growth Quadrangle stands in solidarity with the people of La Paz, Abra in bringing justice to all those involved in the planning and execution of the grenade explosion;

Bernos, the House members of this special committee call upon the La Pazeños to provide information on the whereabouts of the perpetrators to hold them responsible for the fear and terror they have sown and bring back peace within the Province;

transpired in La Paz, Abra, to extend its deepest condolences and sympathies to the families of those who were killed and injured and to express support to Hon. Joseph "Sto Nino" B. Bernos in his efforts to protect his constituents and seek justice for this heinous incident.






